Dear Mr. Benavides:

The following are clarifications to the referenced contract specification. The need for clarification to the specification arises from the fact that the Bayo Canyon site is transected by a corporate boundary, the Los Alamos County-Santa Fe County line. This condition affects three items in the specification Scope Of Work: Item 1.2.5, the as-built site plan of the Bayo Canyon site; Item 1.2.7, the legal description of the Bayo Canyon restricted area; and Item 1.2.8, restrictive covenants.

The clarifications are as follows:

1. The as-built site plan for Bayo Canyon shall include the Los Alamos County-Santa Fe County line and shall show the bearing of that line. Affected sections of the specification are: 1.2.5, 3.4 and 5.2.
2. The legal description of the Bayo Canyon restricted area shall include the location of the Los Alamos County-Santa Fe County line and shall be written such that the restricted area is described as a separate parcel in each county, including providing the area in acres within each county. Affected sections of the specification are: 1.2.7, 3.4, and 5.2.9.



- 3. The restrictive covenants shall be prepared such that one separate restrictive covenant is drafted for the parcel of restricted area located within Los Alamos Canyon, and one separate restrictive covenant is drafted for the parcel of restricted area located within Santa Fe County. These two separate and distinct documents shall be submitted directly to Bechtel. The Seller shall not submit the restrictive covenants to Los Alamos County or Santa Fe County. Affected sections of the specification are: 1.2.8, 3.5, and 5.3.

It is our understanding that no additional cost will be incurred due to these clarifications. Please acknowledge your acceptance of this clarification in writing by August 29, 1982.
