The building pad and underground utilities were left in place, to be removed at a later date. Please note that a copy of the original Closeout Report for the Building 980 Cluster was apparently submitted to Colorado Department of Public Health and Environment (CDPHE) without a cover letter, this letter also formally transmits that report. In 2000, in accordance with the Rocky Flats Cleanup Agreement (RFCA) Rocky Flats Cleanup Agreement Standard Operating Protocol (RSOP) for Recycling Concrete, the 980 was Pad was approved for use as a concrete Rubble storage area. The pad was used for storage of concrete rubble until September 2004. After all of the stored concrete rubble was removed, the 980 Pad was removed; the underside of the pad was surveyed and determined to meet free release criteria.
