Dirty Demolition of Building 705	
Purpose of Contact: Dirty Demolition of Building 705. Prior to the beryllium abatement process in Building 705, beryllium concentration was as high as 779.0 ug/100cm <sup>2</sup> with a number of samples showing concentrations in the range of 8.5 to 145.0 ug/100cm <sup>2</sup> . The beryllium cleaning process in Building 705 included vacuuming, then an application of CC Wet, followed by wiping with clean dry towels in areas not exceeding 6 to 8 square feet at a time.
