<p>Recycling of Carbon Tetrachloride</p>	

Purpose of Contact: Recycling of Carbon Tetrachloride. Approximately 1500 gallons of carbon tetrachloride was removed during the remediation of IHSS 118.1. Two 55-gallon drums of this material, which is approximately 90 percent pure, will be recycled as a substitute for a commercial product and sent to the TSCA incinerator to assist the Department of Energy in testing the incinerator's compliance with MACT standards. The material will not require reclamation before being used. The recycled material is exempt from RCRA/CHWA under 6 CCR 1007-3, Subsection 261.2(e)(1)(ii).
