Modification to Work in the Interagency Agreement (IAG)

Modification to Work in the Interagency Agreement (IAG) - Pursuant to Part 32, Paragraph 191 (Additional Work or Modification to Work) of the IAG, the Colorado Department of Health (CDH), and US Environmental Protection Agency (EPA) hereby notify the US Department of Energy (DOE) that certain Individual Hazardous Substance Sites (IHSS) included in several Operable Units (OU), and the investigatory and remedial work associated with them, are now to be addressed as part of alternate OUs. The rationale for this change is that the listed IHSSs all constitute part of the Original Process Waste Lines (OPWL) and will be investigated and remedied as such.
