Dear Mr. Rast:

In accordance with the provisions of Rule 3745-50-36 of the Ohio Administrative Code (OAC), an annual fee is due upon the anniversary of the issuance date of a hazardous waste permit issued to a facility. Since you have been operating as an existing hazardous waste facility, which should have applied for and received a permit by October 9, 1981, this annual fee requirement is also applicable.

The enclosed "Notice of Annual Fee Due" indicates the amount due and all other pertinent information necessary for submittal of your annual fee for 1994. Your complete fee submittal should include the "Notice of Annual Fee Due" and payment. This submittal is due by July 31, 1994.
