**Announcement of Public Review and Comment Period  
on FEMP Removal Actions**

The U.S. Department of Energy at the Fernald Field Office is accepting comments on six removal actions. Written and oral comments will be accepted for a period of 45 days following publication of this notice. The comment period may be extended by the DOE upon timely request. A responsiveness summary will be prepared and will be included in the Administrative Record File. The comments will be used in the development of the Community Relations Plan for each specific removal action and will also be considered during implementation of the removal actions. The removal actions are being established by the U.S. DOE and U.S. Environmental Protection Agency to prevent, minimize, or mitigate any threat to public health, welfare or the environment by commencing appropriate action without undue delay. The removal actions are:

- Scrap Metal Piles
- Improved Storage of Soils & Debris (Revised Plan)
- Control of Exposed Material in Pit 5
- Waste Pit Area Containment Improvement
- Pilot Plant Sump
- Nitric Acid Tank Car and Area
