

**RECORD OF DECISION (ROD) AMENDMENT
NOW AVAILABLE FOR
FERNALD ENVIRONMENTAL MANAGEMENT PROJECT**

The Department of Energy (DOE) announces a Record of Decision (ROD) Amendment for the Operable Unit 4, Silos 1 and 2 Remedial Action at the Fernald Environmental Management Project (FEMP).

The ROD Amendment was prepared by DOE and approved by the United States Environmental Protection Agency (USEPA) on July 13, 2000, and also received concurrence from the Ohio EPA (OEPA). The Amendment documents DOE's change in remedy for Silos 1 and 2. The revised remedy includes retrieval of the Silos 1 and 2 material, treatment by chemical stabilization, and offsite disposal at the Nevada Test Site.

The Administrative Record for the site, which includes the ROD Amendment plus all documents that formed the basis for EPA's selection of the revised remedy, is available for public inspection at the locations listed below.
