TRANSMITTAL OF THE PROJECT SPECIFIC PLAN FOR DIRECT-PUSH GROUNDWATER SAMPLING IN FORMER SOIL EXCAVATION AREAS – FERNALD CLOSURE PROJECT

The purpose of this letter is to transmit the Project Specific Plan for Direct-Push Groundwater Sampling in Former Soil Excavation Areas at the Fernald Closure Project (FCP). The document is submitted for your review and approval.

This PSP describes the methodology to be used in specific areas at the FCP for direct-push groundwater sampling downgradient of deep soils excavations and foundation removals. This will ascertain if stormwater or perched water infiltrations at the excavations have impacted the aquifer. This PSP is for soils area 3A and 4A, and will establish the protocols for all other soils excavation areas.
