Requirements: In Volume II, Attachment D - Integrated Environmental Monitoring Plan, Section 3.6.1.6 groundwater elevations are measured at 179 monitoring wells. Of these, 102 wells are measured in the first, third, and fourth quarters. All 179 wells are measured in the second quarter when seasonal water levels are high. Wells 2045, 2396, 2880, 2881, 21194, 22301, and 23274, along with other wells, are measured during the second quarter, only.

Variance: Water levels were measured in these seven wells (2045, 2396, 2880, 2881, 21194, 22301, and 23274) during the first quarter of 2014.

Justification: Groundwater elevations are measured at least one time at 179 wells each year. Of these wells, elevations are measured every quarter at 102 wells. Seven wells (80, 2544, 2545, 2546, 2636, 2702, and 2898) are included in the list of 102 wells that elevations are measured every quarter. Access to these seven wells was not available for the first quarter of 2014. In order to compensate for the loss of access and provide data to ensure interpretation of groundwater capture, the seven aforementioned wells (2045, 2396, 2880, 2881, 21194, 22301, and 23274) from the annual list were added to the quarterly list for the first quarter 2014.
