ASBESTOS ABATEMENT PROGRAM AGREEMENTS – DCS-006-01

Dear Mr. Ouimette:

During our meeting on July 26, 2001, we discussed the asbestos abatement program and projects at Rocky Flats. In attendance at the meeting were representatives of Kaiser-Hill Company, (K-H), the Department of Energy, Rocky Flats Field Office (DOE, RFFO), and the Colorado Department of Public Health and Environment, Air Pollution Control Division (APCD). We came to the following agreements:

1. K-H and its asbestos abatement subcontractors will comply with all requirements of APCD's Regulation No. 8 (Reg. 8) when doing abatement work (except permits will not be issued).
2. K-H and its asbestos abatement subcontractors will continue to provide notification to the APCD for our abatement work in accordance with the requirements.
3. APCD will, when the asbestos abatement notice is deemed complete and adequate, return an asbestos approval notice to K-H authorizing the work to proceed.
4. While we feel strongly that the Rocky Flats Environmental Technology Site (Site) is a "non-public access" site, the commitment to comply with the substantive requirements of Reg. 8 renders that issue moot and the APCD will not make any determination.
5. K-H and the APCD will pursue opportunities to reduce administrative burdens related to the notification process including grouping a number of notifications together.
6. APCD agreed to provide updated lists of certified asbestos abatement contractors and personnel to assist K-H in assuring qualified contractors and workers are employed.
7. K-H will limit the individuals authorized to contact the APCD regarding asbestos work to one individual per project as designated below:
