The scope of this demolition will include Tents 5 and 6 on the 750 Pad.

Tents 5 and 6 were anticipated Type 1 facilities. The Reconnaissance Level Characterization Report (RLCR)/Pre-Demolition Survey Report (PDSR) that will be submitted by July 15, 2005, documents the condition of Tents 5 and 6. As stated in the RLCR/PDSR, Tents 5 and 6 did not meet the unrestricted release criteria due to radiological contamination on the outside of the tents. However, there was no radiological contamination on the inside of the tents, so the tents are considered administratively closed under RCRA. Therefore, the tent structures will be managed as LLW during demolition. The controls that will be implemented to demolish the tents will be placed in the work control documents.
