An Interim Measures/Interim Remedial Action is being proposed for the 881 Hillside Area (Operable Unit #1) at the Rocky Flats Plant. The Interim Measures/Interim Remedial Action Plan and Decision Document describes the environmental restoration actions and treatment methods proposed by the U.S. Department of Energy (DOE) for the 881 Hillside Area. The project is located at the U.S. Department of Energy's Rocky Flats Plant, situated near Colorado Highway 93 in Jefferson County, approximately nine miles north of the City of Golden.

This notice invites interested persons to submit written comments during the public comment period which begins with the publication of this notice and ends on Friday, November 10, 1989. Written comments related to the Proposed Interim Measures/Interim Remedial Action Plan may be sent to the U.S. Department of Energy, Rocky Flats Office, and must be received no later than November 10, 1989.
