Comments on the Environmental Evaluation Work Plans for OUs 1, 2 and 5, and Ecology Standard Operating Procedures



Please find attached comments by the U.S. Fish and Wildlife Service and the Colorado Division of Wildlife on the Environmental Evaluation Work Plans for OUs 1, 2 and 5 in addition to the Ecology Standard Operating Procedures (SOPs). Note that these organizations are natural resource co-trustees at the RFP for biological resources.

Please respond to these comments by September 2, 1991 and incorporate the recommendations of the natural resource trustees into Environmental Evaluation Work Plans and Ecology SOPs required under CERCLA and the IAG at the RFP. Should conflicts arise with comments previously provided by EPA and CDH, a meeting will be set up with both the regulators and the natural resource trustees to resolve problem areas. Thus, any conflicts should be brought to the attention of DOE with your responses to comments.

It should be noted that many of these comments are generic and apply to OUs beyond OUs 1, 2 and 5. As a result, Environmental Evaluation Work Plans prepared at the RFP in the future should address the concerns stated in the attached natural resource trustee comments.

Coordination with the natural resource trustees during CERCLA activities is required by CERCLA Section 104(b)(2) and Section 300.135(j) of the NCP. In addition, coordination is recommended by DOE's Office of Environmental Guidance, RCRA/CERCLA Division.


