Ref J K Hartman memorandum (ERD SG 01404) to R Benedetti Operable Unit 1 (881 Hillside) Draft RFI/RI Report Comments

The transmittal letter for the DOE comments on the Operable Unit No 1 (OU 1) Remedial Investigation (RI) report requested an increased effort in the Final RI to model the hydrogeology Specifically DOE directed EG&G Rocky Flats Inc (EG&G) to use Dynamic Graphics 3 D Software to represent geology saturated thickness and contaminant concentrations DOE directed EG&G to present a draft of this 3-D model for OU 1 to DOE on March 15 1993

EG&G cannot present this graphics package to DOE by the date DOE has set forth The volume of data could not be compiled and be useable in that time frame Additionally EG&G does not feel it is prudent to pursue this graphics software until EG&G has studied the appropriateness of this software to the particular OU 1 site conditions That task is being undertaken If EG&G feels that the Dynamic Graphics software is the most appropriate method to present the hydrogeology of the 881 Hillside in the Final RI report EG&G will address the cost impacts for that additional work scope The revised presentation of the hydrogeology by whichever method is chosen will be presented to DOE before final incorporation and development of the report
