As part of our obligations to you as a Natural Resource Trustee for the Rocky Flats Environmental Technology Site (Site), the Department of Energy (DOE) is hereby notifying you of several Site Comprehensive Environmental Response Compensation and Liability Act (CERCLA) related documents that are available. First, enclosed is a copy of the Proposed Plan and Draft Modification of the Site Resource Conservation and Recovery Act (RCRA) Permit for Operable Unit (OU) 1, 881 Hillside Area. Also enclosed is a copy of the final Corrective Action Decision/Record of Decision (CAD/ROD) for OU 1 that was transmitted from DOE to the Environmental Protection Agency, Region VIII (EPA) and the Colorado Department of Public Health and Environment (CDPHE) on September 30, 1996, for their signatures. Finally, enclosed is a copy of the Proposed Plan and Draft Modification of the Site RCRA Permit for OU 3, Offsite Areas.

Notification of the availability of these documents is submitted to you as required by the November 4, 1994, Natural Resource Trustee Memorandum of Understanding, to provide for sharing of technical expertise and cooperation in integrating natural resource protection.
