Environmental Evaluations Conducted at Operable Units in the RFP Plant Site Areas

We request that EG&G prepare two "strawman" Environmental Evaluation (EE) Work Plans for discussion at a RFP Risk Assessment Technical Working Group meeting to be held on February 21, 1992. These "strawman" documents should be prepared for OUs 9 and 10.

The existing EE Work Plans for these OUs were boilerplated from buffer zone OUs including OUs 1, 2, and 5 and are inappropriate for OUs on the plant site since there are either no, very small or poorly developed ecosystems. Thus, we are looking for a level of effort much reduced from that at OUs 1, 2 and 5. Beverly Ausmus, SMS, (301)353-0072, will be available to assist you in this effort.

We also request that these documents be prepared such that they can be distributed to the members of the Risk Assessment Technical Working Group for their review by February 14, 1992. This will allow a meaningful discussion to take place at the meeting and will help to achieve the deliverable date of February 28, 1992, for the Final Phase I RFI/RI Work Plan for OU 9.
