

Interagency Agreement (IAG) Deliverable Documents to be Forwarded to the Natural Resource Trustees

Please be advised that all Rocky Flats Interagency Agreement (IAG) deliverable documents must be forwarded to the natural resource trustees under CERCLA for review and comment concurrently with EPA and CDH. Section 104(b)(2) of CERCLA and Section 300.135(j) of the National Contingency Plan require coordination of response activities with both state and federal natural resource trustees. Coordination includes assessments, investigations and planning. The natural resource trustees will be expected to adhere to the required document review and comment periods specified by the IAG between the U.S. Department of Energy, U.S. Environmental Protection Agency and the Colorado Department of Health which was signed on January 22, 1991.

Note that those IAG deliverable documents where final drafts have been or soon will be approved by EPA and CDH will not undergo modification as a result of trustee comments. However, a mechanism will be developed in the near future to address trustee comments on these particular IAG deliverable documents. Also, for those documents where final drafts or finals exist, it will not be necessary to forward the draft versions.

Table No. 1 (attached) includes the trustees, their addresses, phone numbers, natural resource responsibility and the number of IAG deliverable documents that are to be forwarded.

Table No. 2 (attached) includes a list of RFP documents to be delivered to the Natural Resource Trustees.

We request that all past and current IAG deliverable documents except draft documents be printed, a document list prepared, and draft transmittal letters prepared. Once the transmittal letters are finalized, EG&G will be responsible for delivery to the Natural Resource Trustees. We request that this task be completed by February 28, 1992. Incremental delivery of documents to the trustees will be acceptable.


