LETTER TO THE EPA CONCERNING PLANS FOR IMPLEMENTATION OF THE ENVIRONMENTAL
EVALUATIONS AT OU1, OU2, AND OU5

EG&G recently discussed plans to implement environmental evaluations (EE) for OU1, OU2, and OU5 at Rocky Flats with the Environmental Protection Agency (EPA). Discussions reflected an earlier meeting held with the EPA where EPA expressed concurrence on plans to combine implementation of these three OU EEs through development of a single field sampling plan to be called the Implementation Plan (IP). The IP will provide field sampling details to meet the objectives presented in the OU EE Workplans. Everyone agreed that this will expedite meeting the spring sampling season, and save costs by reducing sampling overlap among the OUs.

This approach to completing the EEs is not specified in the Interagency Agreement (IAG) between DOE and the EPA. Therefore, the EPA recommended that DOE submit a letter requesting concurrence on these plans to which EPA could officially respond.

Enclosed is a suggested letter addressing this issue for DOE to forward to the EPA. Any questions should be directed to Meredith L. Brogden, Ext. 5974.
