

Operable Unit No. 2, Contaminants of Concern, Technical Memorandum Revision

We agree with the proposal presented by your staff (94-RF-04850) for revising the Operable Unit (OU) No. 2, Contaminants of Concern (COCs), Technical Memorandum (TM). Please implement your proposal as soon as possible.

As proposed, the revision will be based on validated data for OU 2, the 1993 Background Geochemical Characterization Report, and the 5-Step Gilbert methodology for data aggregation. We expect the revision to provide consistency to the Remedial Investigation (RI) Reports for OUs 2, 3, 5, and 6. Also, we expect that the cost and schedule impacts will be minimal, as you have stated.

In addition, we expect the OU 2 COC TM and Baseline Risk Assessment to include the risk analysis of ground water for inhalation during domestic use and dermal absorption during bathing exposure pathways. We do not consider the analysis of these two pathways to be additional work scope because they are part of the Risk Assessment Guidance for Superfund (RAGS) Part B.
