South Interceptor Ditch Burn Approval

This memorandum authorizes EG&G to conduct the proposed burn of the South Interceptor Ditch (SID) with the following conditions:

Burning vegetation in the SID will not be performed after May 15, 1992. This deadline is a conservative approach to assure limited or no impact to nesting migratory birds and any populations of the Ute Ladies Tresses that may inhabit the SID.

Follow the requirements of the open burning permit issued to DOE by the Colorado Department of Health (CDH) on February 14, 1992.

A condition in the permit requires EG&G to contact CDH each day prior to burning. Daily approval to burn will be dependent on Denver air quality. To assure that unfavorable weather conditions do not postpone burning past the May 15, 1992, deadline, we ask that you begin burning immediately. Also, please expedite the distribution of this memorandum to the appropriate individuals so that the Integrated Work Control Package can be approved without further delays.
