Implement Pre-Assessment Activities for OU7

Through telephonic conversation I have learned that the EG&G Change Control Administrator expects a memo from the DOE cognizant organization for a change before the change will be processed by EG&G. I support the transfer of funds from OU6 to OU7 for pre-assessment mobilization and planning.

I would also like to comment that the requirement for a memo of this type is burdensome and inconsistent with the Plant Change Control Board (PCCB) Charter intent. Item d. on page 2 of Revision 4 of the PCCB Charter clearly focuses on "...simple and concise..." documentation. As cognizant DOE office we would automatically be involved in the change review per PCCB procedure. To require this additional paperwork, particularly for a relatively small change of \$200,000, is counterproductive to the efficient processing of this change. I would be interested in reviewing the EG&G procedure that describes the internal EG&G Change Control process as it appears your thresholds are overly restrictive.
