DIGITAL LOGGER FILES FOR OPERABLE UNIT NO. 1 - MSB-001-93

Ref: J. K. Hartman ltr (14694) to R. Benedetti, Computer Generated Logs for Operable Unit Investigations, January 4, 1993

In response to the above-referenced letter, the digital logger files for Operable Unit No. 1 (OU 1) were transmitted on September 28, 1992. The Draft Phase III Remedial Investigation/Feasibility Study (RI/FS) report which is currently under review contains additional copies of these logs in Volume III. There are no subsequent revisions that have not been transmitted. The Final Phase III RI/FS report will contain any revisions made to these logs. The digital logger files for OU 2 were transmitted on July 13, 1992 and are the most recent versions. These will also be included as an appendix in the Draft Phase II RI/FS report. The transmittal date for this report is currently being negotiated.

In an effort to facilitate a more regular information flow to DOE/RFO, EG&G Rocky Flats, Inc. (EG&G) is taking the following actions. The standard operating procedure (GT .1) has been modified to include the logger process. This will help to formalize the process with our subcontractors. In February, EG&G will begin a monthly transmittal of logger data for Operable Units (OUs) which are actively collecting borehole data. These OUs currently include 4, 5, 6, and 7. The transmitted data will include both hard copy and digital format. The hard copies will be stamped "Draft" and the diskettes will be dated and labeled "Draft". It is recommended that the draft data be designated for internal use only.
