Please find attached DOE/RFO letter 92-DOE-5560 to EPA and CDH, dated May 22, 1992, regarding the transfer of IHSSs among OUs at the RFP. The OUs affected include Nos. 6, 8, 9, 10, 12, 13, 14 and 15. We request that EG&G take action, as necessary, in a timely manner to implement the transfer of IHSSs.

The primary impacts will be to the Phase I RFI/RI Work Plans at OUs 8, 9, 10, 12, 13, 14 and 15. In addition, this transfer may require funding changes among OUs. Should this be the case, we request that these changes be made through the Plant Change Control Board and that DOE/RFO be kept informed throughout the process.
