Gentlemen:

Enclosed for your review are two copies of the Operable Unit 9 (OU 9) Draft Final Technical Memorandum No. 1, Volume I - Tanks, Addendum to Phase I RCRA Facility Investigation/Remedial Investigation Work Plan (TM1). This addendum is partial fulfillment of the commitments made by the Department of Energy (DOE) in the resolution of the OU 9 active tanks dispute. This addendum constitutes the plan for the investigation of the active tanks, T-8, T-9, T-24, and T-32. DOE agreed to submit this investigation plan within 75 days of dispute resolution. The investigations proposed in this addendum are consistent with the scope of investigation described in the dispute resolution language.

The DOE submitted a plan for the investigation of tanks T-11 and T-30 on November 25, 1994, as agreed on August 5, 1994. We have not at this time received your comments on that plan. Therefore, DOE assumes that the regulatory agencies have no comments on the plan for the investigation of the T-11 and T-30 tanks and DOE will subsequently incorporate the proposed plan for the investigation of T-11 and T-30 into the OU 9 TM 1, Vol. 1 investigation.
