Dear Messrs. Nelson and Warner,

The Colorado Department of Health, Division of Hazardous Materials and Waste Management (the Division) agrees to a 10 working-day extension for submittal of the RFI/RI workplans for Operable Unit No. 3. The units included in the extension are the Solar Evaporation Ponds (SWMU 101), the West Spray Field (SWMU 168), the Original Process Waste Lines (SWMU 121), the Present Landfill (SWMU 114), and the other outside closures. The submittal dates as listed in the January 8, 1990 Environmental Restoration IAG Baseline Schedules and the revised submittal dates are shown below.
