The RFO Safety and Health Division (SHD) has reviewed the subject EG&G document (Reference 1), as transmitted by the referenced letter (Reference 2)

The RFO SHD concurs with EG&G's hazards analysis results for the proposed 750/904 pad storage of sludges from remediation of the Rocky Flats Plant solar ponds. Hazards from this sludge storage are within the safety envelope presented in the January, 1993 draft Final Safety Analysis Report (FSAR) for the 750/904 Pads. Based on the small magnitude of nuclear hazards, there are no nuclear safety restrictions on the proposed pond sludge storage on the 750 pad.

EG&G should provide a definitive schedule for Fiscal Year 1994 actions required to incorporate the findings of the sludge storage safety analysis, as necessary to complete the 750/904 pad FSAR.
