RE: HPGe Standard Operating Procedure (SOP)

Dear Mr. Schassburger,

The Colorado Department of Health, Hazardous Materials and Waste Management Division (the Division), has received your correspondence (93-DOE-02538) dated February 24, 1993 requesting an extension for submittal of the HPGe SOP from February 24, 1993 to March 8, 1993. The Division hereby grants this request.

The Division set the February 24, 1993 date to allow a comprehensive review of the HPGe SOP before submittal of the revised Final Phase I RFI/RI Workplan for OU 13 on March 10, 1993. As you are aware, development of this SOP was an approval condition for the Workplan. Based on subsequent staff discussions regarding this issue and the commitment of DOE to prepare the "Compendium of In-situ Radiological Characterization Methods and Applications" by April 2, 1993, we believe that only slight revision of the existing version of the HPGe SOP is necessary, and submission by March 8, 1993 will be adequate.
