Dear Mr. Bierbaum:

The purpose of this correspondence is to respond to ERM Rocky Mountain, Inc.'s (ERM's) letter dated August 30, 1993 regarding a perceived Health and Safety Plan (HASP) violation which occurred as a result of an audit of ERM field activities conducted by EG&G Rocky Flats, Inc. (EG&G Rocky Flats) Industrial Hygiene (IH) on Monday, August 16, 1993. Based upon ERM's letter, it has been determined that a HASP violation did not occur and a qualified Health and Safety Officer (HSO) was provided by ERM during implementation of the Phase I RCRA [Resource Conservation and Recovery Act] Facilities Investigation/Remedial Investigation (RFI/RI) Work Plan for Operable Unit (OU) 15. The ERM communication problem which resulted in the perceived HASP violation is noted and ERM's resolution of the communication problem is also noted.
