FLOODPLAIN NOTICE FOR IAG FIELDWORK - JMK-0609-91

Certain site characterization activities required under the Interagency Agreement for operable units 1, 2, 5 and 6 will take place in floodplains and/or wetlands. When DOE proposes an action in a floodplain and/or wetlands, 10 CFR 1022 requires that a Notice of Floodplain/Wetland Involvement be published in the *Federal Register* at least 15 days prior to initiation of the activity.

Attached is the draft Notice for DOE's use with regard to these site characterization activities. This Notice has been reviewed previously with P.T. Powell of your staff and modified in response to her comments.

Other documents related to these same projects will be transmitted shortly. They are drafts of a floodplains/wetlands assessment and a statement of findings as required by 10 CFR 1022. In addition, requisite submittals to NEPA Compliance Committee are being developed preparatory to proposing a categorical exclusion for these site characterization activities. The draft Notice is being forwarded now because of the additional time required to have such material published in the *Federal Register*.
