UPDATE OF LETTER DATED JUNE 22, 1987, C.E. WICKLAND TO A.E. WHITEMAN,
RCRA COMPLIANCE INSPECTION

Update page 1 of referenced letter as follows:

- Comment: Training incomplete.
Action: The training of the 178 delinquent personnel has been completed.
- Comment: Knowledge of the Contingency Plan by the Fire Department and local hospitals was inadequate.
Action: The Rocky Flats Fire Department has reviewed the Contingency Plan. Their comments are being incorporated into the Plan. The Plan will be revised by August 31, 1987. Copies of the revised Contingency Plan have been submitted to St. Anthony's North Hospital and the University of Colorado Health Sciences Center.

Update page 2 (Physical Compliance, Areas 1 and 3) of referenced letter as follows:

- Comment: Unlabeled drum in non-designated area outside Building 444.
Action: The drum was labeled and the area was identified as a 90-day accumulation area.
- Comment: A satellite area located outside of a building may not meet RCRA security requirements.
Action: All satellite areas outside buildings are within a secured fence area. CDH is continuing to review this issue to determine if regulations are met.
