In the attached letter, the Colorado Department of Health (CDH), Hazardous Materials and Waste Management Division (the Division), has expressed concern with the lack of notification to the Division prior to field activities at Rocky Flats as required by the Part 37, Paragraph 210 of the IAG.

Please provide the Department of Energy (DOE) with a timely notification mechanism, for transmittal to CDH, which will allow CDH and Environmental Protection Agency personnel the opportunity to regularly exercise their independent verification and oversight authority. Because this mechanism must be presented to CDH by June 8, 1994, please transmit the proposed mechanism to DOE by June 1, 1994.
