In accordance with the Rocky Flats Cleanup Agreement (RFCA), paragraph 146 b, the Department of Energy (DOE), Rocky Flats Field Office (RFFO) is required to *Within 45 days after Congressional appropriation of the [Fiscal Year] FY budget, DOE shall brief [the Environmental Protection Agency] EPA, [the Colorado Department of Public Health and Environment] CDPHE and the [Citizen's Advisory Board] CAB on the budget appropriation and tentative funding allocations for the new fiscal year at the [Work Authorization Document] WAD level* In December 2001, the President signed the Defense Authorization Act of 2002, which includes a total of \$687,453,000 in funding for the Rocky Flats Environmental Technology Site closure project This amount is consistent with the funds requested by the RFFO Additional information on the budget can be found at [http //www.cfo doe gov/budget/02budget/index htm](http://www.cfo.doe.gov/budget/02budget/index.htm) In accordance with RFCA we are prepared to provide a briefing on this subject at your convenience
