Discussion

A draft version of the 371 DOP responsiveness summary was distributed, although many of those attending had received the summary at previous meetings. Some general discussion was held on 371 and then everyone at the meeting was given the opportunity to express any additional concerns. There were no additional concerns, and the stakeholders indicated that their comments had be adequately addressed. Although there were still some global decommissioning issues within the DOP, the stakeholders believed that their comments had received adequate consideration. Steve Tarlton indicated that CDPHE may have some issues to work out. He was informed that the CDPHE Building 371 representative, James Hindman, had participated in a meeting the previous week to resolve the CDPHE comments, and that there was only one outstanding issue related to RSOP notification. The rest of the meeting focused on other questions and concerns related to the waste management program and South Side decommissioning activities.
