The status of the issues of concern are:

- 1) Status regarding issue #2 from CDPHE NOI of May 5, 1998.  
"Submit a Permit Modification to allow storage of non-hazardous liquids on the asphalt in Tent 10 at the 904 PAD"  
*Open issue: Will be investigated next Monday.*
- 2) Status regarding issue #4 from CDPHE NOI of May 5, 1998.  
"Cargo Containers 25 and 26 in Unit 15 A have been leaking since May 1996. The permit requires that the roof has to be in good condition and repairs to be made in a timely manner. Please respond."  
**Closed. Weekly inspection log sheet for 9/21/98 indicated repairs have been completed. A copy of the inspection log sheet has been faxed to Bob Cathel at extension 3578.**
- 3) Status of issue # 2 of CDPHE NOI of 7/16/98.  
"At Building 891, John Law is identified as Point-of-Contact (POC) in the event of an emergency. His TSR indicates that he has not received RCRA Hazardous Waste Training. Because RCRA is an ARAR, Mr. Law should be trained in RCRA waste management if he will continue to be the POC in the event of an emergency."  
**Closed. The points of contact listed at Building 891 are Russ Cirillo and Frank Huffman.**

See if you can resolve these issues for Bob Cathel, ASAP. Contact the unit owner and discuss these issues and then contact Catherine Madore to ensure that the appropriate permit modification is completed.

Unit 15A...leaking trailer...we needed to put together a Class I permit modification to allow RMRS not to have to repair the trailer roof provided no waste was being stored; and A Class 1 Permit Mod to allow for the storage of non-hazardous liquids in Tent 10.

The 7/16/98 NOI was in regard to John Law being on the Emergency Coordinator list for the facility. This is a CERCLA issue...the State did not buy our argument that John had the substantive training for this position. The simplest would be to remove John's name from the list.
