
Considering the age of these reports we request that, at a minimum, all remaining infrastructure be presented on a map, or maps, of RFETS for future stewardship issues or concerns. In addition, it should be recognized that radiological concerns were identified associated with the slab and cement blocks associated with the 452 Trailers, specifically T452B.

Steve,

Just wanted to let you know that in reviewing the Closeout Reports for B280, 282, 284, etc... Although they look better than earlier ones, I do have the following comments:

1) These really do need to contain specific information rather than cookie-cutter language. There needs to be some individualization and specifics provided for each facility, rather than using canned language. These indicate that in all cases the "Utilities were removed to three feet below grade...", even if this was not necessary because there were no in ground utilities to remove. Need to identify the actual activities that occurred.

2) The locations of remaining utilities should be on a map and included with the report for each specific facility, or at the least maps showing the remaining utilities need to be maintained (as indicated) and a specific reference to the specific map(s) that has this information for each specific facility needs to be provided in the report. We should be able to go the records center and retrieve the maps as necessary.

3) B666 - Was suprized not to find the RLCR/PDS concurrence letter attached. This was sent to DOE on Oct 7, 2002. Let me know if you aren't able to find it.

4) 452 trailers - These closeout reports for these trailers need to identify the radiological detections identified and specifically that at least some of the cement blocks and tiedowns were found to be contaminated. They were not recycled but sent off as LLW. As I recall, this was specifically a concern with T452B. Also, weren't some of these trailers sold?

5) T452C - There are several references to the PDS that was supposed to be performed, was it? If so please provide the PDS information. If it was not, then there needs to be some explanation provided for the record.

6) These reports should identify what was removed and what remains. As such, if all of the below grade material (slab, basement, drains, sewers, etc) was removed, this should be so stated. If the basement was left in place, then this should be so stated. This is specifically a concern for B864 and B850, which need to provide a more complete description of what was removed and what remains.
