IAG DELIVERABLE: SUBMITTAL OF THE DRAFT PHASE III RCRA FACILITY INVESTIGATION/
REMEDIAL INVESTIGATION (RFI/RI) REPORT FOR OPERABLE UNIT NO. 1 (OU 1) - RLB-0677-92

As required by the Interagency Agreement (IAG), enclosed is the Draft Phase III RFI/RI Report for Operable Unit No. 1 (OU 1). This document has been prepared to meet the requirements of the IAG and it contains a full presentation and analysis of the complete Phase III RFI/RI data set.

Enclosed also please find:

- 1) Responses to the Environmental Protection Agency (EPA) and Colorado Department of Health (CDH) comments on Baseline Risk Assessment (BRA) Technical Memoranda 6, 7, 8 and 9. These responses are provided in reply to our agreement with the agencies to either respond formally or incorporate their comments in the Draft Phase III RFI/RI Report. This agreement was reached to avoid costly revision of the BRA Technical Memoranda and to facilitate production of the BRA. Based on discussions with EPA and CDH, it is our understanding that disapproval of a BRA Technical Memoranda is not grounds for disapproval of the Draft Phase III RFI/RI Report.
- 2) Responses to EM-463 comments on the June 29, 1992 Draft Phase III RFI/RI Report. Most EM-463 comments related to the incomplete status of the June 29, 1992 Report. They were resolved through the full presentation and complete analysis in this version of the Report or they are addressed in the comments.

The IAG milestone date for delivery of the Draft Phase III RFI/RI Report to EPA and CDH is October 28, 1992. We are prepared to deliver copies of this document to EPA and CDH as soon as we receive your official transmittal letter.
