As required by the Interagency Agreement (IAG) enclosed is the Technical Memorandum describing the exposure scenarios relevant assumptions to be used in the OU 1 Human Health Risk Assessment (HHRA) portion of the Baseline Risk Assessment This Technical Memorandum was submitted initially to the Department of Energy/Rocky Flats Office (DOE/RFO) on December 16 1991 as Public Health Baseline Risk Assessment Technical Memorandum No 1 Exposure Scenarios

The document has been substantially revised based on DOE/RFO's decision to downplay the onsite future-use residential exposure scenario (December 18 1991) Additional revisions have been made in response to verbal comments received on interim revisions from DOE/RFO and Systematic Management Services Inc (January 16 1992) written comments received from Systematic Management Services Inc (January 17 1992) and DOE/RFO (January 28 1992) informal comments from DOE/RFO and Systematic Management Systems Inc (February 6 1992) and a meeting to discuss potential groundwater exposure pathways (February 18 1992)
