Draft Environmental Evaluation Work Plan (EEW), Operable Unit No. 7, Present Landfill

On April 12, 1991, I received a copy of the "Draft Environmental Evaluation Work Plan (EEW), Operable Unit No. 7, Present Landfill". Attached to this document was a request to review and comment by May 3, 1991.

Due to problems associated with: 1) different subcontractors preparing EEWs, and 2) the Ecology SOPs being prepared independently from the EEWs, the EEWs (particularly for OUs 1, 2, and 5) have been different enough that significant modifications have been required. In addition, we have received substantial comments from HAZWRAP ecologists on the EEWs for OUs 2 and 5.

Our current plan, which results from a meeting with both EPA and CDH on April 11, 1991, is to utilize the EEW for OU5 as the "model" document for all other OUs at the Rocky Flats Plant. The due date for submittal of the EEWs to EPA and CDH for OUs 1, 2, and 5 is May 30, 1991.

Since the EEW for OU5 will be the model document for all the other OUs, I recommend that review and comment on this document (OU7) occur after May 30, 1991 when a suitable draft document is available. This should not have an adverse effect on the Final Work Plan due date for OU7 of August 28, 1991.
