TRANSMITTAL OF REVISED DOCUMENTS FOR SITE CHARACTERIZATION WORK AT
OUs 3, 4, 7 AND 9 - JEE-0070-92

Various documents (Environmental Checklist, proposed Categorical Exclusion, Floodplain Assessment, draft *Federal Register* Notice of an Action in a Floodplain and a draft Statement of Findings) have been sent to you recently regarding Site Characterization Field Work for OUs 3, 4 and 9. The Remediation Programs Division has now decided to also undertake site characterization field work in OU 7 in 1992-3. Consequently, we have revised the documents to include the OU 7 work.
