

- 2) Final Phase III RFI/RI Environmental Evaluation Work Plan, 881 Hillside (Operable Unit No. 1), dated May 1991 *→ June!!*
- 3) Phase II RFI/RI Environmental Evaluation Work Plan, Rocky Flats Plant, 903 Pad (Operable Unit No. 2), dated June 1991
- 4) Standard Operating Procedures, Ecology, 5.0, dated May 1991

We request that you, as Natural Resource Trustees, review and comment on the enclosed documents which are oriented specifically toward the biological resources present at the Rocky Flats Plant. Since the field work at Operable Units No. 1, 2 and 5 has already been initiated (due to the July 1992 milestone for the Operable Unit No. 1 draft RFI/FI Report in the Interagency Agreement between DOE, EPA and CDH), timely review of these documents will enable us to make necessary modifications during the early stage of our environmental evaluation activities. We would appreciate receipt of your comments no later than July 19, 1991. If you are unable to provide us comments by this date, please notify Bruce Thatcher of my staff at 966-3532.
