Gentlemen

The U S Department of Energy/Rocky Flats Office (DOE/RFO) is formally submitting to your agencies a Preliminary Draft Pond Water Management Interim Measures/Interim Remedial Action (IM/IRA) Decision Document. Your agencies proposed an Interagency Agreement (IAG) milestone for the submittal of the Draft Pond Water IM/IRA document into the IAG by November 22, 1993. The IAG has not been amended to incorporate this milestone, however, this correspondence forwards this submittal to your agencies for review and preliminary comment.

DOE/RFO is submitting the Preliminary Draft Pond Water Management IM/IRA document without any internal review from EG&G, DOE/RFO, and DOE/HQ. DOE/RFO strongly feels that our goal of attaining a quality, technically defensible document has been sacrificed by the November 22, 1993 target. Despite this, DOE/RFO has made considerable effort in developing a thorough Draft IM/IRA document for pond water management. In good faith, DOE/RFO is submitting this document to your agencies on November 22, 1993. As it now stands, your agencies will be reviewing this preliminary draft document concurrently with EG&G, DOE/RFO, and DOE/HQ.

For clarification purposes, in your November 18, 1993 letter to DOE, your agencies state that DOE did not provide any information on the progress of the Pond Water IM/IRA document. We don't believe this to be true. On June 23, 1993, DOE/RFO sent to your agencies a progress report on the development of the document. Through a phone conversation (November 18, 1993) between DOE staff, Norma I Castaneda and EPA staff, Bill Fraser, that June letter was noted, and faxed to Mr Fraser for further clarification.

DOE/RFO requests that your agencies along with EG&G, DOE/RFO, and DOE/HQ review and provide comments on the draft document by December 17, 1993. Because of a directive by the new RFO Plant Manager for a two-week "stand down" of the RFO plant from December 6 - 17, 1993, DOE/RFO would like to schedule a meeting between your agencies, on either December 20 or 21, 1993, to discuss initial comments on the preliminary draft document, and jointly finalize a schedule for the IM/IRA document. In addition, DOE requests from EPA a status and schedule of the Draft NPDES permit for the Rocky Flats Plant since coordination will be required for the public comment period for both the IM/IRA pond water management document and the NPDES permit.

In conclusion, DOE/RFO strongly feels that communication on this IM/IRA between our agencies needs to be restored, and DOE will do its part to work together with your agencies to improve that effort.
