The Department of Energy has released a Proposed Industrial Area Interim Measures/Interim Remedial Action Decision Document (IM/IRAVDD) for the Rocky Flats, Industrial Area. With the change in mission at the Site, the Department of Energy, Environmental Protection Agency, and Colorado Department of Public Health and Environment believe that the current environmental restoration and environmental monitoring programs need to be re-evaluated for their ability to address the potential future needs of Rocky Flats during decontamination and decommissioning activities.

The Proposed Industrial Area IM/IRAVDD provides a mechanism in which the public can assist the Regulators and Rocky Flats in their evaluation.

A 60-day public comment period has been established running from August 29, 1994 through October 27, 1994. **FAILURE TO RAISE AN ISSUE OR PROVIDE INFORMATION DURING THE PUBLIC COMMENT PERIOD MAY PREVENT YOU FROM RAISING THAT ISSUE OR SUBMITTING SUCH INFORMATION IN AN APPEAL OF THE AGENCIES' FINAL DECISION.** To provide you with an overall perspective on the proposed document, a public information meeting will be held as part of the Quarterly Public Information Meeting on Environmental Restoration activities:
