

EXPIRATION OF INTERIM STATUS FOR RESOURCE CONSERVATION RECOVERY ACT (RCRA)
UNITS - JMK-0759-92



Gentlemen:

Based on 6 CCR 1007-3, Parts 100.20(a), 100.20(c)(6) and 40 CFR 270.73, we believe interim status does not expire on November 8, 1992, for the following operational Rocky Flats Plant (RFP) RCRA units:

1. Units described in the various Rocky Flats Plant (RFP) Part B Permit applications submitted to the Colorado Department of Health (CDH) before November 8, 1988.
2. Units which gained interim status after November 8, 1984, were included in the RFP Part B Permit application submitted to CDH in November, 1986, but were removed from the application prior to November 8, 1988. This refers specifically to the following three units withdrawn from the November 1986 Part B Permit application because it was believed they would not be operated past November 8, 1992:
 - Unit 6, Chip Drum Storage Area, Building 447
 - Unit 21, Pondcrete Storage Area, Building 788
 - Unit 25, Mixed Waste Storage Area, 750 Pad
3. Units which gained interim status after November 8, 1988, and therefore, were not included in pre-November 1988 Part B Permit applications.

The Department of Energy, Rocky Flats Office, hereby requests confirmation or clarification of the above interpretation. We request your response by September 1, 1992.
