On March 23, 1995, the Department of Energy (DOE) provided to you for review and comment, a copy of the Operable Unit (OU) No. 11 Draft Letter Report titled "Colorado Department of Public Health and Environment Source Area Delineation and Conservative Screen and Environmental Protection Agency Area of Concern Delineation." In addition, a presentation on the Draft Report's contents were made to your Project Coordinators on March 24, 1995. Based on the results presented in the report and adequate DOE response to any comments, the DOE proposes the deletion of the following deliverables as required by Section VIII of the Interagency Agreement.

In order to stay on schedule, the DOE requests that you provide comments on the Draft Report to us by Friday, April 7 1995. The DOE also requests formal approval deleting the above TM's.
