Industrialized Area Interim Measure/Interim Remedial Action Schedule

The Environmental Protection Agency and the Colorado Department of Health have approved the proposed schedule for development of the Industrialized Area Interim Measure/Interim Remedial Action (IA IM/IRA). Please see the attached letter referencing the key milestones to be formally incorporated into the Interagency Agreement.

This schedule represents an improvement in project streamlining and will require prompt and consistent interaction between DOE, EG&G and the regulatory agencies. DOE requests that bi-monthly meetings be held between DOE and EG&G to discuss the status of the project until the final document has been submitted to the regulators.
