Only Technical Memoranda No. 1 for both OU 8 and OU 10 have been delivered to the Colorado Department of Public Health and Environment (CDPHE) and the Environmental Protection Agency (EPA). The DOE/RFFO Stop Work Order did not include delivery of the above reports to the regulators. However, RMRS recommends that a copy of the reports be delivered to the regulatory agencies so that the newest information regarding the IA OU sampling is available to them. Upon receipt of written direction from Kaiser-Hill, L.L.C. RMRS will deliver one copy of each report to both CDPHE and EPA.
