EPA/CDH Comments on OU 8 Final Phase I RFI/RI Workplan and Baseline Risk Assessments in RFP Industrial Area

ADMIN RECORD

Please find attached a January 14, 1993 letter, from EPA and CDH containing comments on the December, 1992, Final Phase I RFI/RI Workplan for OU 8. We request that EG&G review the comments and make the appropriate changes to the final document. Note that DOE/RFO and EG&G will need to meet by February 2, 1993, to discuss the disposition of EPA comment nos. 3,4,5,6,7,11 and CDH general comment no. 1.

With regard to EPA comment no. 2 and CDH's comment on Section 8.0 (human health risk assessment), DOE/RFO believes that the residential scenario is not reasonable for the RFP industrial area given the current and probable future uses. Thus, quantitative evaluation of the residential scenario will not be incorporated in the baseline risk assessments at OU's 8,9,10,12,13,14 and 15.

We further request that work plan inserts and written responses to EPA and CDH comments be submitted to DOE/RFO in draft form prior to submitting them to the regulators in their final form. Note that EPA and CDH are requiring that updated figures and texts be submitted no later than February 26, 1993. It is our intention to meet this deadline.
