Removal of Listed Waste Codes from Solution Stabilization Waste



This memorandum is in response to the EG&G letter, "Request to Remove Listed Waste Codes From Solution Stabilization," 93-RF-10208, dated August 26, 1993

RFO is denying EG&G's request for explicit CDH concurrence as CDH has already indicated their general agreement and this is a straight forward hazardous waste determination

RFO is deeply concerned with EG&G's continuing process of utilizing CDH in making waste determinations and the apparent inability to properly make waste determination decisions EG&G must take the initiative to make waste management decisions which are technically sound and cost effective without RFO intervention and persistence

Please advise me as soon as possible of the actions you are taking to resolve this matter
